**Re: Request for Access to Information Under Part II of the  
Access to Information and Protection Privacy Act - File Number PB 191 2017**

---

On March 30, 2017, the City of St. John's received your request for access to the following information:

*" I would like access to a list of marriages at city hall between Jan 1, 2015 and Dec 31, 2016, including the date of the marriage, the city portion of the betrothed's addresses, and the gender of each betrothed."*

The statistical information in relation to the above noted is as follows:

1. Number of weddings performed: 144
2. Number of weddings from people living outside the Province of NL = 11
3. Number of weddings with people living within the City of St. Johns = 85
4. Same sex marriages during this time = 1

Further identifying information other than what has been disclosed herein, would be in contravention of Section 40 (1) (4) and (5) of the *Access to Information and Protection of Privacy Act* cited below:

*Disclosure harmful to personal privacy*

40. (1) *The head of a public body shall refuse to disclose personal information to an applicant where the disclosure would be an unreasonable invasion of a third party's personal privacy.*
- (4) *A disclosure of personal information is presumed to be an unreasonable invasion of a third party's personal privacy where*
- (g) *the personal information consists of the third party's name where*
- (i) *it appears with other personal information about the third party, or*
- (ii) *the disclosure of the name itself would reveal personal information about the third party; or*
- (h) *the personal information indicates the third party's racial or ethnic origin or religious or political beliefs or associations.*

**ST. JOHN'S**

(5) *In determining under subsections (1) and (4) whether a disclosure of personal information constitutes an unreasonable invasion of a third party's personal privacy, the head of a public institution shall consider all the relevant circumstances, including whether*

*the personal information has been supplied in confidence;*

As the provision of the information constitutes full disclosure, to the extent we are permitted to disclose, we now consider this matter completed and will be closing the file.
